American Atheists Minnesota Conference on September 25th

A sure sign that the summer is over is the return of our monthly meetings. In September, however, we will have only a business meeting, from noon to 12:45. We are ceding the floor for the rest of the afternoon to American Atheists for their Minnesota Conference, presented by their state director, Randall Tigue.

Five speakers headline the conference:

GEORGE ERICKSON is one of our freethought community's best known activists. He lives in Eveleth, Minnesota, the base from which he travels the Arctic in his bush plane, the Tundra Cub. He has written several proscience travel books, one of which, *True North: Exploring the Great Wilderness by Bush Plane*, was a bestseller in Canada. See page 7 for a review of his most recent book, *Eyes Wide Open*. He will speak on "Science, Faith and our Global Environment."

CECIL BOTHWELL is the atheist councilmember in Asheville, North Carolina, who was under attack there for being an atheist. Religious bigots tried to have him removed from office but, thanks to the U.S. Constitution, it was not possible. The Secular Coalition for America has named Bothwell one of four national Secular American Leaders. He has written a book critical of evangelist Billy Graham, so he doesn't mind being a truthful troublemaker in the Deep South. His speech topic is "We're All in this Together: Faith and Reason and Their Consequences."

CRYSTAL DERVETSKI, "The Sunny Skeptic" from Waseca, Minnesota, is a dynamic organizer of meetups

for younger freethinkers and is the face of the future of atheism. She will talk about "How to Work with Woo Thinking without Losing Touch with Reality." (Woo is shorthand for pseudoscientific/antiscientific ideas.)

LAVANAM is a director of social work at the Atheist Centre in Vijayawada, India. He is a son of Gora and Saraswathi, founders of Atheist Centre. He has spent his life doing social reform projects, such as breaking down caste divisions and establishing criminal reform projects. Lavanam will speak on "Who Can Save the Future? Finding Safety in Community in a Complex World."

DR. WILLIAM "BILL" VAN DRUTEN will come from Duluth, Minnesota, to add some humor to the conference. He attracted attention a few years ago by opposing Catholic-secular hospital mergers in Duluth — mergers which forced all staff and patients to adhere to Catholic doctrine regarding medical care. He also was the leading campaigner to get a Ten Commandments monument off the Duluth City Hall lawn. He will speak about "The Day Our Play Group Got Redirected."

PRESIDENT'S COLUMN

Memberships

This month I'd like to talk about membership in Minnesota Atheists. Keeping track of memberships (and donations) is very detailed work, and I would like to thank Steve Petersen, Shirley Moll, and Brian Knoblock for the tremendous job they do.

Steve has compiled the following data about members and supporters of our organization:

Individual Memberships:	173
Household Memberships:	35
(representing 53 members)	
Sustaining Memberships:	14
(representing 16 members)	
Life Memberships:	27
Student Memberships:	4
Newsletter Subscribers:	13
Donors not in above categories:	11

This amounts to 297 individuals who financially support us in some way. This is a decline from our all-time high, but it represents an improvement over where we were six months ago.

Last year we saw a decline in membership. I think this can be attributed to a number of factors, among them (in no particular order):

1) The Great Recession.

While we would like to believe that Minnesota Atheists is vital to our lives, the truth is that cause organizations such as ours are generally less important than food, clothing, shelter, and transportation. Let us hope that we are experiencing an economic recovery now.

2) Electronic Newsletter.

Many members have chosen to receive their newsletters via e-mail instead of as a paper copy. We appreciate this, since it saves us money. However, members do not respond to e-mail renewal reminders as well as they do to paper reminders. To overcome this, Shirley Moll has begun sending paper renewal reminders to lapsed members who were receiving enewsletters. This has yielded good results. Thank you, Shirley and renewing members!

3) Ending Our Radio Show. Our "Atheists Talk" radio program first ran from January 2008 to June 2009. It was a natural source of interest in our organization and obvious, concrete example



of something for which we needed money. When the show ended, these impetuses ended as well. Fortunately, we have been able to resurrect our show, and the excitement over it is coming back as well. This is leading to increases memberships and donations.

4) Much of the Newsletter is Free On-Line.

Websites that frequently add new content get more visits than those that don't. In our case, an obvious source for such material is our newsletter. Part of our mission is educational outreach, and many articles in our newsletter certainly fulfill that purpose. But this does raise the question of whether people are not becoming members (or not renewing) because they can get much of our newsletter on-line for free – so why pay for it? However, I, for one, would not like to see us cut back on the great articles we offer publicly on our website. Our hope is that people will see value in our organization that goes beyond the newsletter – and is worth supporting financially.


5) Many, many free events.

Often membership in an organization entitles a person to financial discounts and to attendance at special events. In contrast, virtually everything Minnesota Atheists does or sponsors is free and you don't even have to be a member to participate! Jack Caravela in particular has done a fantastic job of setting up Meetups. I would not want to change having many free events but, as with making much of our newsletter available free on-line, it does beg the question: Why bother to become a member?

Presentation on Religious Indoctrination

On Sunday, July 25, Grant Steves gave perhaps his last public presentation for Minnesota Atheists, before he moves to Wisconsin in September. Speaking to about 40 attendees at the Golden Valley Library, Grant deconstructed the processes of religious conversion and deconversion, based on his personal journey as a Jehovah's Witness, Roman Catholic, and finally an atheist. He spoke in particular detail of the emotional context of conversion, and how cults are adept at manipulating new adherents with fear and release from crises in their lives.

After Grant's presentation, several members of the audience recounted their personal conversion and deconversion stories.

PZ Myers visits the Twin Cities

Paul Zachary (PZ) Myers, atheist activist and writer of the fabulously popular science blog Pharyngula, spoke to packed houses (attendance in the high 60s) at two Critical Thinking Club meetings in early August. His presentation to the St. Paul chapter was ironically titled "Science and Atheism: Natural Allies." His exposition showed that the two were in fact antithetical. He argued that no new facts could ever be discovered that will disprove evolution; rather, in the future there will be "Evolution Plus," that adds new mechanisms to current theory. Further, no facts can be advanced that could ever prove the existence of a god,

since that discovery would merely be another entity in the natural world, amenable to the empirical investigation of science.

The next night in Stillwater he presented an introduction to the mechanisms driving evolution, much as he would to one of his classes at the University of Minnesota at Morris. He discussed how the importance of mutation is overestimated in the popular understanding, as genetic assimilation, accommodation and the Baldwin effect are more important for changing the distribution of genes in a population in response to an alteration in the environment.

Federal Court Finds California's Proposition 8 Unconstitutional

Federal District Court Judge Vaughn Walker's ruling in *Perry v. Schwarzenegger* early in August that overturned California's Proposition 8, a constitutional amendment that defined marriage as a union between "a man and a woman," set off a predictable storm of outrage from the religious right. Tony Perkins, the President of the Family Research Council, complained on CBS' *Face the Nation* that Judge Walker should have recused himself because he is "openly homosexual."

Judges are expected to recuse themselves from cases in which they have a conflict of interest, and could personally benefit from their ruling. But clear lines are hard to draw when the standard is simply any condition that might cause others to question the judge's impartiality. If the religious right claims that a homosexual judge would be partial to a decision favoring same-sex marriage, should opponents of Proposition 8 not question the impartiality of a heterosexual judge, who would be inclined to protect what religious conservatives claim is the "special status" of traditional marriage? To assert that a homosexual judge must recuse while a heterosexual judge need not is to prejudge the merits of the case. Of course any experience may influence a judge on any case, but a personal benefit would only be evident if Walker were to apply for a marriage license. I rather like the idea of insisting that all Christian judges, or even all god-believing judges, recuse themselves from Establishment Clause cases. Realistically, I think that this idea has the same merit – legally and practically insufficient - as the demand for Judge Walker's disqualification.

But Perkins' assertion that Judge Walker is "openly homosexual" is a gross overstatement. He has never made any public statement on the question of his sexuality, and certainly none to the press. All of the assertions that he is gay are based upon an unattributed report in the *San Francisco Chronicle* that it is "an open secret." That article reported no sourcing of any

kind – neither witnesses, nor a boyfriend, nor a confidant. The story is based on nothing more than the unverified allegation of an "open secret."

Bryan Fischer, host of the American Family Association's weekday radio program *Focal Point*, wrote in

a column on RenewAmerica.com that Judge Walker wanted to "become a media star, the Judge Ito of the homosexual movement." That is blatant misrepresentation to "poison the water" of the meticulous decision of *Perry v. Schwarzenegger*.

Most reputable American newspapers refuse to be a party to "outing" public figures as homosexuals. Many have published standards requiring that, unless the person has stated his or her sexual orientation, they will not report it, even if other news organizations have already. Nevertheless, when right wing organizations demand that Judge Walker be disqualified because he is gay, newspapers like *The New York Times* report it. The right wing has thereby succeeded in manipulating the mainstream press into spreading their smear campaign. In assessing Walker's political leanings, no one mentions that he was appointed to the federal bench first by Ronald Reagan, then again by George H.W. Bush, and that his confirmation was opposed all the while by Senate Democrats.

At least in small part, I was disappointed in Judge Walker's decision. The reason that Minnesota Atheists supports same-sex marriage is that the rights of gays and lesbians are the target of political attack based upon religious prejudice. While the decision at one point observes that "(t)he state does not have an interest in enforcing private moral or religious beliefs without an accompanying secular purpose," yet, in his decision, Judge Walker never mentions the dominant role that

Book Review

Those of us who know him know that he has led an adventurous life and has often been on the barricades in the defense of Freethought and Humanism, frequently wielding his pen. This book is the results of George's remarkable life and the


varied short-form literature he produced.


Eyes Wide Open is an unusual anthology. It contains every genre of short literary works: stories, sketches, poems, antidotes, essays, bios and more. It contains a variety of types of writing: fictional and factual, historical and personal, travel adventures, critiques of homegrown absurdities and atrocities, and so on. At

various point you'll be reading George's letter to the editor, then something satirical, then something provocative, then imaginative, and so on.

A sense of history and humanism are present in this book, but it's really about humanist living by someone

imbued with the values of Freethought and Humanism. This is an inspiring example of the humanist way of life or, more exactly, of a humanist way of experiencing life fully and boldly. This is not about humanity in the





abstract. As the subtitle puts it, this is about "living, laughing, loving, and learning."

There is some science in this book. George is a science-literate person, and I especially appreciate that, because while I am proscience, much of my reading has been in history and literature, and I am pretty thin on scientific knowledge. George expertly treats scientific topics in a concise and lucid way—topics such as plate tectonics and the functions of water—and then makes his points.

I also appreciate George's vivid descriptions of wonders most of us will never see and experiences most of us will never have. George has

been all over the world and experienced many things. Thanks to his writing ability we can vicariously take in these things.

George excels at finding or making up good stories and telling them succinctly. He also has a good crap-detector, which he applies to the religious charlatans and political reactionaries of

our troubled times. For good

measure, he adds his views on many of the social issues that bedevil our world.

Footprints on the Web

My digital footprint has been causing me a little stress lately now that I have joined a very competitive labor market vying for a job. Not that I'm ashamed of my digital footprint, but I feel that my outspoken support for atheism, science, and civil

liberties (via secularism) may be a turnoff to prospective employers doing a little Google research for "Eric Jayne" in "Minnesota". I offer this apologetic article, in defense of my online atheistic activity, to prospective employers who may have stumbled upon this piece from their online search efforts.

In case you're not familiar with the concept, a *digital* footprint is the trail you leave behind from whatever online activities

you have engaged in. To be sure, I'm not

ashamed of my digital footprint but given the unpopularity of atheists in our culture and negative stereotypes that are promoted, I feel the need to persuade those who celebrate diversity in the workplace to extend that sentiment to atheists.

If there is any doubt of the social and cultural challenges atheists encounter perhaps a recent University of Minnesota study (www1.umn.edu/news/news-releases/2006/UR_RELEASE_MIG_2816.html) can mitigate some of that doubt. The study shows that atheists are the least tolerated minority group in the United States. While tolerance continues to grow for race, religion, and sexual orientation, atheists are seen as being amoral, self-serving, hedonists who don't care about community. It's not surprising that the study shows that the more educated an individual is, the more accepting they are of atheists.

I can't speak for all atheists, but one of the reasons why I shed my Christian beliefs is because I simply couldn't get past the ethnocentric idea of us vs. them that biblical stories and religious teachings promote. My compassion for people—and the mass community we call humanity—couldn't get past the idea of eternal and inhuman punishment based on

beliefs derived from one's cultural upbringing. When I researched religion even further I learned that religious texts were erroneously copied thousands of times over by scribes and translated from Aramaic to Greek to Latin and finally into

English before the printing press was ever invented! Before I knew it, I had established a foundation of secular-humanistic moral philosophy and rational-based skepticism.

It wasn't until I learned about Minnesota Atheists that I was able to talk freely among other like-minded freethinkers about how frustrating it is to be ostracized by family and friends when we come out of the

proverbial closet as atheists. While atheists often are accused of being pompous and condescending I submit that we

atheists are often on the receiving end of anger-filled condescension from theists—who seem to claim great metaphysical and cosmological knowledge—for the simple act of rejecting a belief in their god. I think Stephen F. Roberts makes a great case for believer/non-believer camaraderie when he said: "I contend that we are both atheists. I just believe in one fewer god than you do. When you understand why you dismiss all the other possible gods, you will understand why I dismiss yours." It's simple, to the point, reasonable, and not in the least bit insulting.

So, whether you, prospective employer, are a private faith-based or public secular human service agency, you can rest assured that when you hire me you'll be getting a thoughtful, compassionate humanitarian who shares in all the glory of human rights and social justice your religion promotes. Additionally, because I simply believe in one fewer god (or prophet) than is popularly accepted, you have an opportunity to make your workplace a more diverse place of employment; and you don't have to worry about improper proselytizing because atheists don't have anything to proselytize!

In addition 18 lawgivers from history, Menes, Hammurabi, Moses, Solomon, Lygurgus, Solon, Draco, Confucius, and Octavian (south wall); Justinian, Mohammed, Charlemagne, King John, Lois IX, Hugo Grotius, William Blackstone, John Marshall and Napolean (north wall), appear on the north and south walls of this courtroom. They affirm that no religion or civilization is endorsed or preferred.

Parenthetically, it should be pointed out to Newt Gingrich and all the FOX Islamophobes, who oppose the Muslim Community Center to be built five blocks from 9/11 ground zero in New York city, that Mohammed is honored in the courtroom of the United States Supreme Court Building.

Congresswoman Michele Bachmann and others have alleged that James Madison, the Father of the Constitution said, "We have staked the whole of all our political institutions upon the capacity of mankind for self-government, upon the capacity of each and all of us to govern ourselves, to control ourselves, to sustain ourselves according to the Ten Commandments of God." This statement appears no where in the writings or recorded utterances of James Madison and according to Madison scholars is completely contradictory to his character. Madison was a strong proponent of separation of church and state. religious organizations played in the Proposition 8 campaign.

Plaintiffs in this case named as Defendants Governor Arnold Schwarzenegger, Attorney General Edmund G. Brown, and other state officials. All of these defendants, however, declined to defend Proposition 8. But the organization that orchestrated the campaign, protectmarriage.com –Yes On 8, A Project Of CaliforniaRenewal, stepped forward as Defendant Intervenor, and conducted the defense. The decision notes that the campaign advertisements from this group "conveyed to voters that same-sex relationships are inferior to opposite-sex relationships and dangerous to children," a claim that they did not make at trial. Judge Walker took no notice, however, of where the funding and staffing came from.

Latter Day Saints (Mormons) contributed about half of the \$40 Million raised by the campaign, plus 80-90% of the door-to-door volunteers. Substantial funding was also provided by the Roman Catholic Archdiocese of California and the Knights of Columbus; the Union of Orthodox Jewish Congregations of America; the Eastern Orthodox Church; and the American Family Association, Focus on the Family and the National Organization for Marriage, which are run by Evangelical Protestants.

I recommend that everyone read the decision at http://www.scribd.com/doc/35374462/California-Prop-8-Ruling-August-2010. It is based on solid findings of fact and law that the appeals court will find difficult to overturn. The ban on same-sex marriages in California, however, remains in effect until a ruling on the appeal.


