n past columns I have L criticized President Obama's Advisory Council on Faith-Based and Neighborhood Partnerships. It was Obama's attempt to correct the flaws of the White House Office of Faith-Based and Community Initiatives created by George W. Bush, which was nothing more than an apparatus for

dispensing government funds to evangelical Christian ministries for charitable social programs. Obama promised to create a partnership between religion and government, to strengthen religion and to give it a role in setting the national agenda.

Obama promised, as soon as he took office, to stop funding faith-based organizations that practiced religious discrimination in employment. He ignored his promise, however, and did not put it on the agenda for the Advisory Council. That first council completed its work with a 163-page document delivered in March of 2010, containing reports on Reform of the Faith-based and Neighborhood Partnerships Office, Economic Recovery Domestic Poverty, Fatherhood and Healthy Families, Interreligious Cooperation, Environment and Climate Change and Global Poverty and Development. In the two years since, however, I have heard nothing more about the Council. That first Council disbanded, and Obama has to date appointed only 12 of the 25 members of the second Council. The new Council will not convene until all the members have been named.

The reason for the long delay is not at all clear. The White House claims that 70% of the recommendations in the original report have been at least partially implemented, and that Obama is committed to launching the second Council. If the Council were at all in operation, the White House

would have loved to point to it in response to political sniping that he is conducting a "war against religion."

A big story for conservatives in March is an apparent investigation by the Internal Revenue Service into the activities of Tea Party groups. At issue is whether they qualify for 501(c)(4) tax exempt status. They are crying foul because of questions that the IRS has sent them, asking about their members, donors and activities, and for Board meeting minutes.

This is an issue that would normally not warrant mention in this column, as it is not directly a question of church/state separation. However, Minnesota Atheists is itself a tax exempt organization, and we are quite aware of the prohibitions against direct electoral participation. We want to be assured that non-profit groups that oppose us on separation of church and state also play by the rules.

We are not truly on equal footing. Minnesota Atheists' tax exemption derives from Section 501(c)(3), as an educational organization. We are permitted to engage in issue advocacy, including very limited lobbying, but not to endorse candidates for office or to contribute to a political campaign. By contrast, organizations that are exempt from taxes under Section 501(c)(4) are afforded rather greater political leeway. While they can do more lobbying than a 501(c)(3), they are classed as "social welfare" organizations, such as business associations and labor unions, and may not have the primary purpose of political advocacy.

Yet if you go to many web sites run by these Tea Party chapters, or read the literature they publish and distribute, you find that they give every impression that their reason for existence is entirely for political campaigning. The IRS must determine if their actual conduct is primarily for the benefit of their members and society as a whole, or electioneering. Donations made for a political campaign not only do not qualify for a tax write-off, donors of more than \$13,000 annually may also be liable to pay a 35% gift tax.

The Tea party chapters claim that the IRS is trying to intimidate them with their questions, to frighten them away from the exercise of their constitutionally

#### MINNESOTA ATHEISTS' ANNUAL DAY OF REASON CELEBRATION

#### Thursday, May 3, Noon-1:00 p.m. Minnesota State Capitol Rotunda, St. Paul

From noon to 1:00 p.m. on Thursday, May 3rd, Minnesota Atheists will once again hold a "Day of Reason" rally inside the Minnesota State Capitol Rotunda. This is the seventh year that we have held this celebration of the separation of state and church to protest the "Day of Prayer" event held at the same time outside on the Capitol steps.

While any group of citizens may hold a rally on the Capitol steps, what we are protesting is the government endorsement of this religious event. We are also celebrating the triumph of reason over faith when it comes to understanding the universe.

There are many ways in which the separation of state and church is violated. This year we will focus on the denial of equal rights to gays and lesbians, especially when it comes to civil marriage.

This November an amendment will be on the ballot asking Minnesotans to enshrine bigotry in our state constitution by limiting civil marriage to heterosexuals. Last summer Minnesota Atheists joined a coalition called Minnesotans United for All Families to oppose this amendment.

Minnesota Atheists was also the only organization to file a friend-of-the-court brief supporting three samesex couples (collectively known as Marry Me



Minnesota) who are suing the state to legalize samesex marriage and to have such marriages that are legally performed outside of Minnesota recognized by our state.

At our Day of Reason rally this year we will be partnering with members of Marry Me Minnesota and their lawyers to highlight and protest this continuing religion-based discrimination against our fellow citizens. We will also have speakers from Minnesota Atheists

and the Humanists of Minnesota, including the everpopular Grant Steves.

In addition, if we can find one or more gay or lesbian couples willing to do it, we will have a brief,



secular, commitment ceremony, and note that the Capitol building, even in its current state of disrepair, does not collapse.

Although the state legislature is scheduled to be through with its work in April, there are many who think they will still be in session for our Day of Reason celebration, and thus will be present to appreciate our patriotic support of the First and Fourteenth Amendments to the U.S. Constitution.

The National Day of Reason was instituted as a protest against the National Day of Prayer, which was established by an act of Congress in 1952, and fixed as the first Thursday in May by a law enacted in 1988. The National Day of Reason is observed by secular groups across the country in support of separation of church and state.

Help us remind our government officials that they represent all citizens. Every voice counts. If you can take a long lunch break, or have the free time, we would appreciate your coming to support this event.

With each Day of Reason our turnout has increased. With your help, we hope to continue that tradition. Our elected representatives take notice, as well as school groups and others visiting the State Capitol, and our presence ensures that when any media outlet covers the Day of Prayer, our Day of Reason will get equal time.

protected right to freedom of speech. They say that they are guilty of nothing more than the political advocacy which is the right of every citizen, for which they are receiving Gestapo-like suppression. But they are in fact not being subjected to a criminal investigation. The FBI has not been called in. All of the questions that have been raised by the IRS are for information that they need to decide if these groups satisfy the requirements for a tax exemption. If it is too odious to answer the questions, they should simply withdraw their applications.

# Traditional Clothing Amendment Added to November Ballot

Almost one year after state lawmakers passed the Marriage Amendment Bill, and just days after the house and senate passed the Voter ID Bill, it appears that Minnesota voters will be asked to approve a third constitution-altering ballot measure.

Lawmakers in both chambers rapidly worked out a narrow vote over the weekend to pass a traditional clothing bill. Like the marriage and voter ID bills, this will bypass the governor by being put on the November ballot for voters to decide. If voters approve the bill it will be illegal for women to wear pants (including blue jeans) and men to wear dresses (including kilts).

Additionally, the proposed clothing amendment will ban the manufacturing, selling, possession, and wearing of clothing made from blended fabrics.

"Most of our merchandise will be considered contraband if the voters approve this law," Maplewood Burlington Coat Factory manager Stephanie Hawkins said. "If it passes I may have to move to a more tolerant state like Iowa."

All states, including Iowa, have no gender-based restrictions on clothing and still allow the sale and manufacturing of blended fabric.

Unlike most states, however, Iowa legalized same-sex marriage after the state's Supreme Court unanimously approved it in 2009. Iowa became the third state in the nation to extend marriage rights to gays and lesbians.

If the traditional clothing law passes it will be the first of its kind in the United States. "My parents came here from Somalia to escape authoritarian intolerance," said Fahima Abdi. "These sex and gender amendments are eerily reminiscent of the strict burka and marriage laws enforced by the fundamentalist warlords who took over my homeland over 20 years ago."

Groups that support the Minnesota marriage amendment are also raising substantial money for the clothing amendment. The Minnesota Catholic Conference has already raised \$265,000 to help campaign for the clothing amendment and the Minnesota Family Council said that their traditional clothing fund is up to \$73,000.

"We believe most Minnesotans support a traditional culture where gender is clearly defined and where we're all forbidden to enjoy the same-sex pleasures that many of us desire," says Tom Prichard, President of Minnesota Family Council.

"Our creator intended men and women to procreate and raise families without the confusion or satanic-induced curiosity of gay and lesbian sexual activities," Prichard added. "How is our society to survive if mothers wear blue jeans and fathers wear pink shirts?"

The Minnesota Family Council's website cites a variety of bible verses supporting their views including Deuteronomy 22:5, which says God detests women in men's clothing as



well as men in women's clothing. Another bible verse quoted on the council's website is Leviticus 19:19, which says God forbids the donning of clothes "woven of two kinds of material."

Some lawmakers insist that the clothing amendment is not rooted in discrimination. "This is

not about hating women who wear pants and men who wear dresses, nor is it about intolerance," said Rep. Tara Mack, R- Apple Valley, chief author of the clothing bill. "I am faithful that we can have a respectful dialogue on this issue and allow the people of Minnesota to decide whether they want to live in a state condoning gender related abominations against God."

The textiles and human rights lobby are both decrying the law as an unconstitutional overreach of government. "Both federal and state courts have found same-sex marriage bans to be unconstitutional," says Sarah Warbelow, director of Human Rights Campaign. "It should be painfully obvious to anyone with a pulse that the courts will find a law restricting clothing based on gender to be unconstitutional as well."

Carlos Moore, executive vice president of the American Textile Manufacturers Institute, says it makes no sense for lawmakers to spend time on gender-related issues.

"This is America", Moore said. "And in America we should be free to wear what we want and marry

who we want as long as we're not hurting anybody else."

Mr. Moore also said that he has concerns about what damage could be done to Minnesota's economy if retailers are forced to pull their fabric-blended clothes from the shelves.

Sen. Warren Limmer, R-Maple Grove, is confident that there won't be a negative affect on the state's economy.

"People will still need clothing", Limmer said. "They'll just have to wear state approved clothing for their state approved marriages, which means they'll be pumping money into the economy when shopping for appropriate clothing at the shopping mall."

Minnesota led the nation in voter turnout with 77.8 percent during the last presidential election in 2008. With a presidential election, a U.S. senate seat up for grabs, and an unprecedented three ballot measures, voter turnout might even surpass the 2008 turnout.

## Open mind would have room for nonbelievers

Mitch Pearlstein ("The American mind is open," Feb. 27) painted a picture of a diverse American populace where we "have more than enough respect ... for each other's religious commitments."

What Pearlstein failed to mention is that religious Americans do not extend the same generosity and warmth to nonbelievers as they do to fellow believers.

While the Constitution forbids a religious test for elected office, 53 percent of Americans would not vote for a well-qualified atheist presidential candidate (Gallup poll).

And according to research recently published in the esteemed Journal of Personality and Social Psychology, believers rated atheists and rapists as about equally trustworthy.

Prejudices fade when people get to know each other on a personal level. Until believers and nonbelievers can talk openly and civilly about their respective worldviews, I am afraid that the American mind will not be as open as Pearlstein would have us believe.

# March Meeting Review: Jen McCreight

ennifer McCreight was the guest speaker at the Minnesota Atheists monthly meeting in March. Jennifer McCreight is a PhD student studying genomics. She is also the popular science, feminism, and atheist blogger at Blag Hag (http://freethoughtblogs.com/blaghag).

Jennifer's talk was entitled "God's Lady Problem." In this talk Jennifer equated the descriptions (as written in their respective holy books) and religious dogma surrounding the gods of all major religions with that of a violent domestic partner. Like domestic someone who perpetrates violence, gods demand that we love only them, that we give them our money, they threaten to hurt us if we don't do exactly as thev sav. and they emotionally psychologically torture and guilt us into staying with them. As Christianity is the major religion in the United States, Jennifer spoke a great deal about the Christian god, but she also turned her eye on Judaism, Islam, Buddhism, and even Jainism.

In the next part of her talk, Jennifer focused on the steadily escalating war on women that we are seeing play out in our politics and in the rhetoric of the upcoming presidential elections. From there she

moved into the realm of, what I am dubbing, Atheism's Lady Problem. She touched briefly on some of the recent blogosphere debacles including Elevatorgate (it defies description in this short piece, but you'll find more than you even wanted to know by Googling the term) and some of Reddit's obnoxious behavior on R/Atheism. In the broader atheist community we have had our run-ins with anti-woman language and behavior, or perhaps unintentionally offensive behavior driven by male privilege, but the speed of the internet has also made it easy for us to police ourselves and call out these offenses when they occur. Unlike religions we do not as a movement condone or codify this type of anti-woman behavior.

A large crowd turned out to hear Jennifer's talk; the room at the Roseville public library was filled. The question and answer session was fast-moving and took up all the time allotted for Q&A. Jennifer introduced our group to some new ideas and ways of the thinking about how women are perceived and treated in religions, our government, and our own atheist movement.



Freethought M.C. (M.C. standing for "Man of Conscience") creates hip-hop music that invokes compassion, spirituality and a language of reverence while grounded in reason, community, social responsibility, science and ethics.

Though he was raised Baptist, Freethought M.C. grew up questioning religion and philosophy. He became a Zen Buddhist at age 11, studied comparative

religion in his 20s and now identifies as a Humanist and a Unitarian Universalist. His lyrics are influenced by Dawkins, Hitchens, and Harris, as well as science fiction. His music also tackles political and social issues such as corrupt governments, nuclear warfare scenerios, African genocide, and the Iraq war.

In 2009 Freethought M.C. released two albums: Diary of a Humanist and Modern Humanology, followed by Freethinker Vol. One in 2010, and at the end of last year he released The Categorical Imperative Strikes Back. During the show, Freethought M.C. discussed his music and his activism in the African American atheist movement. Carl Hancock produced the show. He and Michelle Los conducted the interview. Brianne Bilyue hosted.
