## **Justice in a Just World**

Ts the world we live in fair? We tell children it isn't, though we often do that just to get them to be quiet.

The idea that the world is fair is embedded in many of the world's religions. Galatians six tells us that we shall sow what we reap, that if we do good, we will receive our reward. In context, this reward is clearly supposed to arrive after we die. However, that hasn't stopped many believers and traditions from assuming God will grant them favors in this world if they are only pious enough.

The concept of karma explicitly tells us that we are rewarded or punished for our actions. Again, the consequences sometimes come to us in this life, sometimes in the next. Either way, the events of our lives are dictated by our own worthiness.

Even without religion, many of us believe that the world is somehow balanced. We let go of the gods who are supposed to make the world just, but we don't—or can't—let go of the idea that good things happen to good people and bad things happen to those who have somehow earned their problems.





was no doubt that she is an atheist as she describes her surprise in herself as she bluntly tells her son "There is no God."


At the end of the meeting, the authors lined up along some tables to sign listeners' copies of *Atheist*

## News and Notes

I never expected God to be an issue at the Democratic National Convention. Christian conservatives are obviously a core constituency of the Republicans, and their stamp was unmistakable on everything that transpired at the Republican National Convention a week earlier. I expected the Democrats to make routine obeisance to religion that should infuriate everyone who values the separation of church and state, which would, however, attract no particular notice.

To my surprise, on Wednesday morning the networks reported that the platform had been released with no reference to God or to Jerusalem as the capital of Israel. This became the exclusive focus of the *Jay Sekulow Live* radio program that morning, and Republicans were quick to spin it as proof that Democrats were out of touch with the America's religious core. It was a tempest in a tea pot, as party platforms are nothing more than appeals to special interest groups. That no platform ever mentions the separation of church and state, or expresses respect for atheists, only proves our political insignificance.

The platform committee had dropped language from the 2008 edition that acknowledged God. Fabulous! That certainly made the platform more inclusive, deleting a gratuitous dismissal of atheists.

Predictably, as soon as the Republicans crowed about the deletion, the Democrats bleated abject apologies. As soon as the convention opened on Wednesday, the platform chair, Ohio Governor Ted Strickland rose to correct the omission of the reference to God. "I am here to attest and affirm that our faith and belief in God is central to the American story and informs the values we've expressed in our party's platform. In addition, President Obama recognizes Jerusalem

as the capital of Israel and our party's platform should as well."

He did not read the two proposed insertions from the 2008 platform, because they were projected onto a

large screen. The first read: "We need a government that stands up for the hopes, values, and interests of working people, and gives everyone willing to work hard the chance to make the most of their God-given potential." The second was "Jerusalem is and will remain the capital of Israel. The parties have agreed that Jerusalem is a matter for final status negotiations. It should remain an undivided city accessible to people of all faiths."

Party brass apparently expected perfunctory approval for these insertions. I find it astonishing that the convention parliamentarian had not required them to be separated into distinct votes. National Convention Chairman Antonio Villaraigosa, the mayor of Los Angeles, called for the vote, which required a two-thirds majority to pass.

The video of this tableau is posted to YouTube, so you can still view it. The "No" votes were louder than the "Ayes," clearly discomforting Villaraigosa. Reading his script from the teleprompter, he started to move forward with the proceedings, but then decided to retake the vote. This time the "Aye" vote was louder than before, but again it did not match the "No" votes. Signaling clearly that the vote was unacceptable, Villaraigosa tried a third time. The "Aye" vote was even louder than before, but again the "No" vote was louder and more enthusiastic.

## Vote No...Twice

oters will be going to their polling place in a few short weeks. Besides voting for state legislators, U.S. legislators, and president, Minnesotans will also be voting on two constitutional amendments. One of the amendments is unfairly restrictive and based on mythical beliefs that breeds—and stems from—irrational fear. The other amendment would constitutionally ban same sex marriage.

Of course, the anti-marriage amendment is horribly restrictive and has its own myth-based, fear-mongered roots but the atheist case against it appears more obvious. That's why I want to take a moment to discuss the proposed voter restriction amendment from the critically thinking atheist perspective. My feeling is that the voter restriction amendment conflicts with the skeptical point of view and humanistic values.

Before I make my case, allow me to first explain that as with the anti-marriage amendment, the voter restriction amendment is officially a non-partisan issue. Even though tax-exempt 501 (c)3 non-profits can legally take positions on voter restriction, Minnesota Atheists has not. They have, however, taken a position that opposes the anti-marriage amendment and it's celebrated on this year's popular t-shirt design that proclaims "Minnesota Atheists supports Marriage Equality".

The other thing I want to make clear is that I am speaking only for myself and my views do not necessarily reflect an official position of the Minnesota Atheists. Now, let's get on with it...

The three biggest issues with the voter restriction amendment are:

- 1) It's spending a lot of money to solve an insignificant problem.
- 2) The language of the proposed amendment is vague and unclear.
- 3) It could likely disenfranchise tens of thousands of voters.

Beginning with the first issue, you might remember the 2008 senatorial and 2010 gubernatorial statewide elections. Both of these elections led to exhaustive, litigious recounts where thousands of ballots and voter rolls were scrutinized. One of the

recurring claims made by voter ID proponents is that thousands of felons voted illegally and Minnesota leads the nation in voter fraud. As skeptics, we should be asking, what and where is the good evidence for this?



There is

evidence, but it's bad and poorly extrapolated. It's based on matching the names of felons on one list to the names on the voter rolls. So if the name "John Smith" appears on the felon list and the name "John Smith" appears on the voter rolls: Voila! That's a possible felon who voted. Not only was it uncertain that the correct John Smiths were being matched, but it was also unknown which felons had reduced probations that would have restored their voting rights.

If we parse through the slop of bad information and pull out the facts, we will understand that 156 convicted felons (not thousands) have been prosecuted since 2008 for illegally registering to vote. Before we start mandating voter restriction laws that would prevent tens of thousands of residents from voting, it would do us good to understand that there were about 5 million votes cast since 2008. That means that the number of felons voting illegally is about 0.003 percent—or 3 out of every 100,000.

According to a recent billboard near Albertville that depicted a large foam hand with an extended index finger, the state of Minnesota is "#1 in Voter Fraud." How did the voter ID supporters come up with that claim? They used the results from the aforementioned recount investigations. One rather significant detail that doesn't get mentioned is that there is no other study or investigation from any other state to compare findings with because no other state has had two recent statewide recounts. This is like me

saying that I'm number one in chess because I routinely beat my 9-year-old son at the game. I haven't compared and tested my skills against anyone else but I remain undefeated. The burden is bogusly placed on others to prove the claim wrong. Without having a similar study to compare with, the billboard may as well have said, "Minnesota is #1 in Coldest Snow." The reasons for the voter restriction amendment are based on a myth; or at the very least they're based on overstated, unproven hyperbole. It's important to note that the voter restriction amendment would do nothing to stop ineligible felons from voting and, furthermore, there hasn't been a single prosecution of voter impersonation in Minnesota.

In regards to the language of the proposed amendment, it's incredibly vague and short on specifics. For example, voters are asked to approve a requirement mandating that voters present a valid, government issued ID. This appears to mean that students attending private colleges wouldn't be able to use their school IDs as they can now; and, if you recently moved, your picture ID could be invalid if it hasn't been updated with your current address. Many of our elderly neighbors living in nursing homes

would need to take on the burdensome and expensive task of tracking down their birth certificates and other documents in order to get an updated, valid government-issued picture ID. Furthermore, the language doesn't specify what, exactly, will be determined as "valid" and there's no mention of how it will affect absentee voting. Policy makers tell us to trust them to flesh out the details next year—AFTER the election. It seems unreasonable to my skeptical senses to ask voters to tweak the state constitution without knowing these important details first.

One of the greatest features of the Minnesota Atheists is that it is a very open and transparent group that encourages all of our members to vote, share ideas, and serve on the board or at some other leadership capacity. We encourage active citizenship and celebrate diversity in and out of our organization. As with the Minnesota Atheists organization, our nation's governance works best when participation is not subjected to unnecessary, repressive restrictions due to superstitious and paranoid beliefs.

For these reasons I will vote NO on both restrictive amendments in November.

## Atheists Cook Dinner for Homeless Families in St. Paul

Minneapolis, St. Paul, Bloomington, and just about every city, suburb, and community throughout Minnesota. With rising rent, low apartment vacancy rates, foreclosures, and scarce housing resources, low-income families have faced extraordinary devastation. Perhaps even more devastating is that children and youth account for nearly half of all the homeless people in Minnesota. The average age of that half is 6 years old (Wilder Research – April 2010).

In Ramsey County, the first point of contact for all homeless families is the Family Place which is a secular nonprofit in downtown St. Paul. They provide youth enrichment, employment counseling, housing advocacy, and they directly arrange shelter for homeless families.

On Saturday, September 15<sup>th</sup> fourteen atheists gathered at the Family Place to cook and serve dinner to about 40 guests, half of which were children. Minnesota Atheists member Jill Carlson was our kitchen leader and developed the menu that featured chili, garden salad, corn bread, fresh fruit salad,

chocolate chip cookies, milk, and lemonade. A couple members brought fresh veggies from their own personal g a r d e n s t o contribute to the salad.

After a couple of hours in the kitchen the 14 of us brought the food out to the dining area. We then had the unique experience of sitting with the families and



dining with them family style. After dinner we cleaned up the dining area and kitchen. Then about half of our group followed up with a couple of tasty cocktails at the Bulldog Restaurant a couple blocks away in Lowertown St. Paul.

If you are interested, we will be doing another cooking and dining at the Family Place on November 24 which is the Saturday after Thanksgiving. Space is limited to 14 people so be sure to check out our Meetup site to RSVP.









## Marriage Amendment

The following letter to the editor was published in *The [New Ulm] Journal,* Sept. 11, 2012, by Minnesota Atheists' member Vanita Mishra.

Homosexuality is an enduring pattern or disposition of attraction to the same sex, and falls entirely within the normal spectrum of human sexuality. It would be akin to the color of one's eyes or skin, and just as impossible to change. And: A marriage is, and has always been, a legal/contractual agreement. Anyone who has decided to vote "Yes" on the marriage amendment should consider the following:

- 1. The current existing Minnesota Statute still holds that marriage is between one man and one woman. A "Yes" vote does not change that, and is therefore not necessary.
- 2. Since a marriage is a legal contract, it has no place on a ballot. This legal contract automatically gives a couple several important rights, involving ownership of property, inheritance, adoption, and the right to be legal next of kin in medical decision making.
- 3. Objection to same-sex is almost always based on ignorance, and religious bigotry. Many fallacious "arguments" are put forth, such as:

"A marriage is meant to produce children, and this is not possible in a same sex union." If this were the case, the marriage of a heterosexual couple that chose not to or cannot have children should not be recognized. A man and a woman who want to marry should be forced to have tests to prove they are fertile before a marriage license is issued, and a death row inmate who has no chance of consummating his or her marriage should not be allowed to marry.

"Once we allow gay marriage, we will be on the slippery slope to polygamy/people wanting to marry their pets, etc." The issue at hand is, and has always been, the union of two consenting adults who love each other and want equal legal rights. Rational people can agree that one's parakeet or Fido would not qualify.

"Families/the children will suffer." There is absolutely no evidence that children raised by a same-sex couple fare worse that those raised by a heterosexual couple. There is no evidence that heterosexuals are leaving their marriages

in droves and entering same-sex marriages in states where same-sex marriages have been legalized.

4. Discrimination against gays, lesbians, and bisexuals, which includes attempts to deny them their same legal rights as other citizens, is anti-humanity and anti-family, and un-American. It puts tremendous amounts of totally unnecessary stress on these individuals, and increases the risk of mental health problems, and even suicide attempts. It tears families apart.

While the exact percentage is not known, it is possible that anywhere from 2 to 10 percent of the US population falls in the LGBT category. And that is quite a few people right here in New Ulm.

It is easy to sustain anti-gay bigotry by painting a parody of a "gay lifestyle". The reality is that gays, lesbians and bisexuals are people you meet and interact with every day. They are your coworkers, your local business owners and your health-care providers. They may be your siblings, children, grandchildren, or future generations. They may be that tormented child who is already being bullied in school about his or her sexuality, and who is now wondering why those nice neighbors who hand out candy every Halloween have that "Yes" sign on their lawn. Discrimination against gays, lesbians, and bisexuals produces real suffering.

- 5. Besmirching gays, lesbians and bisexuals as "sinners" and pedophiles is false and ridiculous. There is really no good secular and fair argument against same-sex marriage.
- 6. People who oppose same-sex marriage also need to be aware that one of the most prominent supporters of this issue is the US Military.

Nowhere in Ms. Ringhofer's letter did I read that she was questioning the right of anyone to post a "Yes" lawn sign, or even to vote "Yes" on the Marriage Amendment. She was simply pointing out the bigoted and painful nature of the message. And she is right.



Realizing that the convention was not going to follow his script, Villaraigosa overruled the delegates, announcing that "In the opinion of the chair, two-thirds have voted, the motion is adopted and the platform has been amended as shown on the screen."

The dissent may have been primarily from supporters of Palestine, who opposed recognizing Jerusalem as part of Israel. Since the vote on the two insertions was combined, we cannot know for sure. The Democratic Party depends on the support of Jews much more than the support of Palestinians, however, so this seems unlikely. I think that it is quite likely that the true reason for the revolt was a matter of pride. The delegates were upset with the party leaders for jumping in response to every tortured grievance from the religious right. The amendments amounted to an apology that surely rankled them.
